This is a summary of the Annual Report for the IUPAT District Council 21 of Northeastern PA Annuity Plan, Employer Identification Number 23-2481824 Plan No. 001. This Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust fund and are funded with contributions to the Fund by contributing employers and by investment earnings.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$8,569,322 as of May 31, 2022 compared to \$8,934,024 as of May 31, 2021. During the plan year, the plan experienced a (decrease) in its net assets of (\$364,702). This decrease includes unrealized appreciation or depreciation in the value of the plan's assets, that is, the difference between the value of the plan's assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$447,420 including employer contributions of \$873,629 and income (losses) from investments of (\$426,209).

Plan expenses were \$812,122. These expenses included \$159,110 in administrative expenses and \$653,012 in benefits paid to participants and beneficiaries. A total of 358 persons were participants in or beneficiaries of the plan at the end of the plan year.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

- An accountant's report.
- Financial information and information on payments to service providers.
- Assets held for investment.
- Insurance information, including sales commissions paid by insurance carriers.
- Information regarding any common collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which a plan participates.

You also have the right to receive from the plan administrator, on request and at no charge, a statement of the assets and liabilities of the plan and accompanying notes or a statement of income and expenses of the plan and accompanying notes, or both. If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, whose address is set forth above, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
