**SUMMARY ANNUAL REPORT FOR PERIOD
MAY 1, 2021 TO APRIL 30, 2022**

This is a summary of the Annual Report for the IUPAT District Council No. 21 Welfare Fund, Employer Identification Number 91-2036994 Plan No. 501 for the period May 1, 2021 to April 30, 2022. This Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

INSURANCE INFORMATION

The plan has contracts with Aetna Signature Administrators, HM Life Insurance Company, United American Insurance Company, United Healthcare Insurance Company, Amalgamated Life Insurance Company and HCC Life Insurance Company to pay health, stop loss, life insurance and accidental death & dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending April 30, 2022 were \$6,111,311.

IUPAT District Council No. 21 Welfare Fund has committed itself to pay health, medical, prescription drug, vacation, disability, vision and dental claims incurred under the terms of the plan. The total claims paid for the year ended April 30, 2022 were \$49,794,114.

BASIC FINANCIAL STATEMENT

The value of plan assets, after subtracting liabilities of the Plan, was \$43,561,869 as of April 30, 2022 compared to \$50,403,180 as of May 1, 2021. During the plan year, the plan experienced a decrease in its net assets of (\$6,841,311). This decrease includes unrealized depreciation or appreciation in the value of the plan assets, that is; the difference between the value of the plan's assets at the end of the year and the value of assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had income of \$50,923,017 including employer contributions of \$45,763,015, employee contributions of \$6,575,660, realized (loss) from the sale of assets of (\$72,558), (losses) from investments of (\$1,983,302), and other income of \$640,202.

Plan expenses were \$57,764,328. These expenses included \$1,858,903 in administrative expenses and \$55,905,425 in benefits paid for participants and beneficiaries.

- Information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which a plan participates.
