This is a summary of the Annual Report for the International Union of Painters and Allied Trades District Council No. 21 Annuity Fund, Employer Identification Number 23-7390182, Plan No. 003. This Annual Report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Benefits under the plan are provided by a trust fund and are funded with contributions to the Plan by contributing employers and by investment earnings.

BASIC FINANCIAL STATEMENTS

The value of plan assets, after subtracting liabilities of the plan, was \$219,241,663 as of June 30, 2025 compared to \$199,876,220 as of July 1, 2024. During the year ended June 30, 2025, the plan experienced an increase in its net assets of \$19,365,443. This increase includes unrealized appreciation or depreciation in the value of the plan's assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$35,299,355, including employer contributions of \$13,315,132, rollover contributions of \$180,861, realized gains on the sale of assets of \$541,716, and earnings from investments of \$21,261,646.

Plan expenses were \$15,933,912. These expenses included \$1,269,255 in administrative expenses and \$14,664,657 in benefits paid to participants and beneficiaries. A total of 5,178 persons were participants in, or beneficiaries of the plan at June 30, 2025.

The charge to cover the copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan, whose address is set forth above, and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
